Device Systems

A. PRE-QUALIFICATION CRITERIA

Bidding entities are advised to read this section carefully and be sure that all requested information is included in the submission. Evaluators will neither make assumptions nor draw inferences regarding incomplete information. The submission of incomplete information may result to rejection of proposal.

The pre-qualification criteria will include but limited to the following:

- Company profile, contact name, verifiable address, active telephone numbers, active email addresses in the name of the company and organization's administrative structure.
- Evidence of company registration with the Corporate Affairs Commission (i.e. Certificate of Incorporation; forms CAC2 and CAC 7, Article and Memo of Incorporation).
- Tax Identification Number (TIN) with evidence of tax remittance (tax clearance certificate) for the last three years.
- IV. Evidence of VAT registration with evidence of VAT remittance.
- V. Bank Account confirmation letter from company/ organization's bankers.
- VI. Audited financial statements of the organization for the last three years.
- VII. Regulatory authority license (where applicable).
- VIII. Verifiable list of similar jobs/supplies successfully executed in the past (inclusion of letters of award and completion certificates an added advantage.
- IX. Recommendation/referral letter from three reputable organizations attesting to satisfactory performance of contractual obligations (services provided). This must be consistent with the documents provided in vii above).

B. PROPOSAL SUBMISSION:

Individual consultants/ organizations interested in participating in the planned solicitation process shall submit requested documents as attached files to the email address indicated below. Attachments should not exceed 10MB in size, in Adobe PDF format.

All completed pre-qualification documents can be submitted to the designated e-mail address <u>eoibids@tns.org</u> with clear subject "**Prequalification of Vendors**" NOT LATER THAN 12:00PM (Nigerian Time) Monday August 25th, 2025.

Bidders are required to include as part of their submission the specific States and Reference Number they are interested in. For Example: *Prequalification of Vendors-Language Translation Services (TNS/NG/020)*. Bidders who are interested in more than one category in which they qualify are free to do so, and should indicate the Reference Number on their submission.

TechnoServe may at its discretion extend the due date and time for submission of EOI by amending this solicitation. Any submission received by TechnoServe after the due date and time indicated will be rejected.
